Respected president on the dais, beloved circle secretary com B.D.Nath, our CWC member & adviser-CHQ com S.K.dalai, my dear comrades of this august house. I put forth my report before you for discussion & approval.

Organisational Activity

1. During my tenure a good number of agitation programmes have been organized on the calls given by CHQ. I am thankful to all the comrades of Rourkela for their active participation to make the programmes successful. Some of the important agitations were during Dec'2008, June'2010 and Dec'2010. I am also very much thankful to our Circle Secy for his valuable instructions and guidance during such programmes.
2. I along with the Organising secy attended the CEC at Bhubaneswar and put forth our problems strongly before the body.
3. We had the privilege to hold our CEC at Rourkela on 1st Aug'2010. The CEC was successfully conducted due to immense and disciplined efforts of all our comrades. I am very much thankful to the circle body on behalf of our Rourkela comrades for giving us the opportunity to hold the CEC at Rourkela.
4. Presently we have 30 comrades, that too only after induction of three no of newly promoted JAOs . When I took over the charge of Dist Secretary , it was brought to my notice in the 1st CEC itself that both the CHQ & Circle Quota were pending for the last 18 months . However as on date we have cleared CHQ quota, Circle quota & both legal as well as AIC fees up to the month of Dec,2010. Once again I reiterate in this conference for the knowledge of our comrades that the monthly subscription per member has been enhanced from rupees 30 to rupees 50 w.e.f. Jan,2011 as passed in the AIC at Kolkatta on 1st of Jan,2011. The distribution is Rs 30 for CHQ, Rs 10 for Circle & Rs 10 for branch. Hope all the members will co-operate in this regard.

BRANCH ACTIVITIES:

1. I along with President, Organising secretary & treasurer organized meetings with SSA head frequently for day to day problems & I am very much thankful to the GM,TD, Rourkela for solving the problems. However due some reason or other, we have not been able to conduct regular general body meetings . I hope in future this will be taken care of.
2. Com N.k. Pattanaik & com A.K.Nayak got posted at Rourkela station in spite of strong denial from branch administration, since administration was of the opinion to post at least one comrade at Bonai/Rajgangour as SDOT.
3. Com A.k.Ray Com J.K.sahu ,Com Mrs. Bose & myself got posting to the place of choice on officiating/adhoc promotion. In case of Com J.K.Sahu , we left every hope of being reposted at Rourkela cancelling the order for posting at Dhenkanal .However the case was finally settled , the transfer was cancelled & he got posted at Rourkela , only during his adhoc promotion. I thank GM(HRD) , BBSR for his kind consideration after my request over phone and GM TD,Rkl for his timely intervention.
4. Com S.K. Sahu, Com Kissan, Com Sambhu have got their place of choice at Rourkela on their promotion to JAO & thank to comrade A.k.Ray for timely & continuous pursuance with GM(fin),BBSR for the postings.
5. I am very much thankful to our CS for his valuable intervention & dealing for request transfer of Com pal , AO from Rourkela to Kolkata , since he is in desperate need for the transfer due to his acute personal and family problems. Now I sincerely request our CS to take up request transfer case of Smt S. Mukherjee , AO to Kolkata ,who has completed the tenure of 2 years in last Jan . She has genuine medical problem as she has undergone major operation in Kolkata & hospitalized for two months..
6. After retirement of some of our comrades 6 nos of quarters got vacated , out of which four belongs to RSP & one is in the 2nd floor of GM residence, other at E-10B complex. We have been able to get allotted the Type-V quarter in GM building complex \$ in favour of SDE© & the one in E-10B,but due to absence of timely information & clear cut guidelines, we have not been able to allot the RSP quarters in favor of some of our comrades, who were in desperate need . I feel

personally sorry for the affected comrades. But I hope due care and intervention will be taken while dealing with such cases in future.

7. I put forth before our Circle Secy particularly CHQ legal Advisor to intervene personally on top priority for promotion of Com B.K.Patra, A.O.. He has been dropped for more than one year for no fault of his own. Although ha has represented the facts and figures for his innocence to the GM(Finance), no action has been taken to resolve the case.

It is observed that after successful completion of tenure period in tenure circles, Comrade Bilung did not get his 1st choice place of posting to Koraput, instead he has been posted at Rourkela against his third choice. It is therefore requested to our circle secy to keep a close watch in future so that our comrades get their first choice place while getting posted in our circle.
9. Our Comrades holding the post of SDOs were finding difficulty in attending broadband faults without the laptops. After long persuasion with the GMTD, Rourkela the laptops have been supplied to the SDOs concerned with Broadband activities.
10. Finally, I am very much thankful to Com A.K.Ray, Org. Secy, Com. N.K.Sinha and Com. A.K.Nayak, Com. N.K.Pattnaik and Com. K.C.Mohanty who have taken all the pains in organizing this Divisional Conference a grand success.
