Subject : Promotion of JTOs to the grade of SDE(Telecom) in BSNL against 67% seniority-cum-fitness quota (Promotion quota)

In pursuance of BSNL, CO, New Delhi Order No. 2-15/2011-Pers.II, dated 30.03.2011, the Chief General Manager, Eastern Telecom Region, Kolkata is pleased to issue the following promotion and posting order from JTOs to the grade of SDE (Telecom) against 67% seniority-cum-fitness quota (Promotion quota) in the IDA pay scale of Rs. 20,600-46500/- from the date they assume charge of the higher post and until further orders, provided that:

- i) They have been absorbed in BSNL on permanent basis.
- ii) No Disciplinary/Vigilance case is pending against him/her and VC is not withheld in terms of instructions contained in GOI (DOP&T) OM No. 22011/4/91-Estt(A), dated 14.09.1992.
- iii) The currency of any penalty against the officer is over.
- iv) The officer is on deputation to TCIL or any other Organization.
- v) The officer has not retired on the date of issue of the order.

1. Information in this regard may be brought into the notice of this office immediately and concerned officer should not be promoted or relieved for joining without specific orders from this office.
2. The officers indicated at Sl. No. 1, 3 to 7, 9, 11,12, 15 & 16 who are officiating in the grade of SDE (Telecom) are reverted to their substantive grade before taking over the charge of SDE (Telecom) on promotion against 67% seniority-cum-fitness quota (Promotion quota).
3. JTOs who have opted for DOT or who have not given any option for their absorption may not be promoted. Such cases may be reported to office.
4. All Unit Heads concerned may please ensure that the promotion/posting orders in respect of the officers found eligible after fulfilling the above conditions are issued in time to enable the officers to join their promotional assignment, and the officer is relieved within the prescribed time limit of 40 days (including the joining time) from the date of issue of Corporate Office order.
5. In case the officer concerned fails to join the promotional assignments within the prescribed period of 40 days, he/she should not be allowed to be relieved or join the post thereafter. In such a case, the promotion order shall become inoperative and such cases shall be reported to this officer for further necessary action. Further, no request for modification of promotion order shall be entertained. Accordingly, promoted officers should join the assigned posting without fail.
6. All Unit Heads concerned are further intimated that the pendency of request of the officer for modification of the promotion/posting order should not be taken as ground for holding up the implementation of the promotion order in respect of the officer.
7. The leave, if any requested by the officer, who has been posted on promotion to different circle, should not be allowed. If any officer desires leave, he/she can apply for leave to new Head of Circle under whom he/she has been posted only after joining the new post and new CGMT will sanction leave, if it is considered justified under normal case.
8. Discrepancies regarding name, gender, present place of posting, etc. may be intimated to this office immediately for issuing necessary correction. A copy of charge report submitted by the promoted officer may be endorsed to this office also.
9. The date on which the above order is given effect may be intimated to this office with a copy to AGM (Pers.II), BSNL, ND. A consolidated report of the officers who have been relieved/have joined their new postings may also be sent immediately on expiry of 40 days from the date of issue of this order.
10. The aforesaid promotion order is subject to the final outcome/decision in any law suit(s) pending before any courts(s) regarding their regulation of seniority.
11. The particulars of officers may also please be updated in the HRMS as soon as they join as SDE(Telecom) on promotion on the basis of this order.
12. Pay fixation on promotion be done as per prescribed norms.
13. The aforesaid JTOs promoted to SDE(Telecom) should submit an undertaking (copy enclosed). The posting order should be issued only after receipt of undertaking from the concerned JTOs.
